**Recitation from the Holy Quran**

**i) Approval of LCCI Election Schedule 2023**

The Secretary General briefed the house that the LCCI Election process will start from 7<sup>th</sup> August, 2023 and Election Schedule would be placed on Notice Board of LCCI and website as per law. The provisional list of voters will be displayed on August 12 and final list of voters will be issued on September 10, 2023. The nomination papers will be received on 14<sup>th</sup> September and withdrawal of nomination papers will be received on 24<sup>th</sup> September. The Election of Corporate Class and Associate Class would be held on **28<sup>th</sup> & 29<sup>th</sup> September, 2023 respectively and Annual General Meeting will be held on 30<sup>th</sup> Sept. 2023.** He requested the house for approval of the LCCI Election Schedule 2023. The resolution was put before the House, and the

majority of the House approved the Election Schedule 2023 without any amendment.

The Chair apprised the house that **Rs.50,000/-** will be charged from the candidates along with nomination papers (non-refundable) as Election Fee which was already approved by the Executive Committee and DGTO in 2020.
